Mr. Barbic spoke about Scott McCarty's qualifications for the Fire Science position. He said he has been in contact with Waubensee Community College regarding dual and articulated credits and Mr. McCarty is fully qualified to meet their requirements.

Friday, September 6 will be a transition day for Mr. McCarty and he will start in the classroom on Monday, September 9, 2019.

Dr. Shimp moved and Dr. McGuire seconded a motion to hire Scott McCarty as the 2019-2020 full-time Fire Science instructor, at a salary of \$43,627 (BA, 8 years per CBA contract). Mr. McCarty will begin on September 9, 2019. The full year contract is \$43,627 for 180 days. Mr. McCarty will work 162 days in the 2019-2020 school year. The rate per diem is \$242.37. The modified contract will be \$39,263.94. Roll call was taken. All ayes. The motion passed unanimously.

Mrs. Moore said she appreciates Mr. Barbic's efforts in filling this position and has total confidence in his recommendation. She publicly thanked him for a job well done.
